pairIncubator will accept founders working on Web-related projects only. If your project is not Web related, please do not apply. If you are not sure if your project qualifies, please e-mail info@pairincubator.com.

The application deadline is January 4, 2010. Applications received after this date will not be considered; however, they may be bumped to the next session for consideration

To apply, complete this application in full, then postal mail the completed application along with a complete business proposal in both electronic (on a CD) and paper formats to the following address:

The business proposal must contain complete details on your concept, project/technology goals, potential users of your technology, financial projections, and any other information that you feel will help your project/technology to be selected by pairIncubator. Please note, pairIncubator will not sign an NDA.

All applications and business proposals will be reviewed between January 4 and 8, 2010. Promising applicants will be notified via telephone and invited to meet with the pairIncubator team during the week of January 11, 2010.

Following these meetings, if accepted into the pairIncubator program, you will be notified the week of January 18th. If accepted, the main contact listed on your application will be notified over the telephone and via postal mail. The postal mail package you receive will have additional information on the program and next steps.

Participants are expected to devote 40+ hours per week to the development of their project for the duration of the pairIncubator session. If you are unable to do this for any reason, please do not apply for pairIncubator at this time. To be eligible to participate in the program, you must answer "Yes" to all of the items listed below.
